## Hunting Waiver of Liability, Assumption of Risk, and Indemnity Agreement

In consideration of being permitted by the Quinault Indian Nation to participate in the Guided Black Bear Hunt on the Quinault Indian Reservation, I hereby, for myself, my heirs and assigns, release and forever discharge the Quinault Indian Nation, its officers, employees, and agents from any and all lawsuits or actions, claims or demands by reason of any damage, loss, death or injury to myself or to my property arising from said hunting activities.

I agree to hold harmless and indemnify the Quinault Indian Nation from and against all lawsuits, claims, actions, cost or legal fees expenses that may be incurred in defending any lawsuit or claim I or a third party may bring, in respect to death, injury, loss or damage to myself and/ or my property, or incurred by a third party, howsoever caused arising out of or in connection with my hunting activities on the Quinault Indian Reservation.

I understand that hunting carries with it both known and unforeseen risks that could result in various degrees of injury, including, but not limited to loss of the use of limb(s), death, damage to property or to third parties. I acknowledge that these conditions are inherent risks to the sport of hunting and agree to assume all risk and hazards associated, and I further agree to bear all costs of medical attention rendered to me from an injury arising from my hunting activities on the Quinault Indian Reservation.

By my acceptance of a Guided Bear Tag, I consent to the jurisdiction of the Quinault Indian Nation and agree to abide by its codes and regulations. I also agree that the Quinault Indian Nation Tribal Court shall have exclusive jurisdiction over any lawsuit or claim regarding my hunting on the Quinault Indian Reservation and expressly consent to the personal and subject matter jurisdiction of the Quinault Indian Nation Tribal Court.

I acknowledge and agree that this waiver does not in any way constitute a waiver of the sovereign immunity of the Quinault Indian Nation.
