## LAPTOP ASSISTANCE APPLICATION FOR SCHOOL YEAR 2020-2021

The purpose of this distribution is to assist with remote learning related to partial or full distance learning measures implemented by their school districts.

### POLICIES & GUIDELINES

#### Eligibility

- Student must be a Quinault Tribal member with a permanent enrollment number or who have been approved for enrollment by the enrollment committee by November 30, 2020, pursuant to current tribal enrollment and service eligibility policies. Tribal enrollment will be verified by staff.
- Students ages 3-19 and enrolled in an education center and/or accredited alternative education program in grades 12 or below or any college students who are currently enrolled in an accredited program.
- Students pending approval of enrollment at 2021 GC meeting who met the deadline by 11/30/20

#### Requirements

Parent/Guardian if applicable, must submit a completed application and supporting documents to determine eligibility. (see dates below)

- Student will need current verification of school enrollment on school letterhead, or an official class schedule from the school they will be attending. **(STUDENTS ENROLLED IN TAHOLAH, QUEETS CLEARWATER, LAKE QUINAULT, PACIFIC BEACH, NORTH BEACH, OR QIN HEADSTART WILL NOT BE REQUIRED TO SEND SCHOOL ENROLLMENT VERIFICATIONS. QIN WILL CONTACT THESE MENTIONED SCHOOLS FOR A MASTER REGISTRAR**
- For custody disputes and court orders, please submit supporting court documentation. (In cases of custody or other disputes, decisions will be made based on the information submitted.)
- Applications must be received by December 31, 2020.
- Supporting documentation must be received by December 31st before laptop will be distributed.
- Please do not send CIB or tribal enrollment card, we have a list that will verify enrollment.

#### Laptop Disbursement

Designated dates in January will be advertised for a drive thru pick up. For those members who live 140 miles outside of the reservation, certified mail will be used.
